Subject: MOHAKA CO-DESIGN PLAN DEVELOPMENT - PROJECT BRIEF

Reason for Report

 This agenda item presents the co-designed project brief which has been developed by HBRC staff and tangata whenua for the development of the Mohaka chapter of the Kotahi plan (resource management plan for the Hawke's Bay region). The co-designed Mohaka provisions will give effect to the National Policy Statement for Freshwater Management 2020 (NPS-FM).

Executive Summary

- The project brief sets out the co-design process for developing specific provisions for the Mohaka catchment (including the Taharua and Waihua catchments), including all tributaries.
- 3. The brief has been reconsidered and amended by HBRC staff and Ngāti Pāhauwera Development Trust (NPDT) staff since it was brought to the RPC in October 2020. It was noted at the October meeting that the Project Brief required greater tāngata whenua input prior to it being endorsed by the RPC.
- 4. The Project Brief, now titled 'Mohaka Co-Design Plan Development' still draws on key elements of the initial iteration, however, it has been amended significantly to reflect the new way of working with the NPDT and tangata whenua in the Mohaka catchment. The project brief highlights the Maori-led workstream as well as the parallel HBRC and connecting workstreams that have been woven together to ensure that tangata whenua are actively involved in developing the plan provisions. This includes developing how Te Mana o Te Wai applies to the catchment and how the management of freshwater will give effect to this. Additional resourcing is being provided to enable NPDT to lead this work on behalf of relevant tangata whenua interests in the Mohaka catchment.
- 5. The RPC is reminded that Government has indicated a commitment to repealing and replacing the Resource Management Act 1991 with new legislation before this project is completed. The Mohaka project brief is sufficiently flexible to respond to such legislative change, as is the Kotahi Plan development.

Strategic Fit

6. This freshwater management work contributes towards achieving the strategic outcomes for land, water and biodiversity: Climate smart and sustainable land use, biodiversity and water quality, safety and climate resilient water security.

Background

- 7. The previous Mohaka Project Brief was brought to the RPC in October 2020, the supporting paper described the background to this project (the paper can be found here). It was noted at the October meeting that the Project Brief had not successfully been codesigned and required greater tangata whenua input prior to it being endorsed by the RPC. The draft project brief was received 'subject to the endorsement of all co-design partners'. Consequently, work has been ongoing on the Mohaka catchment policy development, largely in respect of ensuring that iwi/hapū (via NPDT) are appropriately resourced and have the technical expertise appropriate for them to be actively involved in the plan development.
- 8. The following narrative provides the RPC an update on progress made since October 2020. It should be noted that this narrative is not directly relevant to the endorsement of

the 'Mohaka Co-Design Plan Development – Project Brief' but rather should provide the RPC with a high degree of comfort that the project has continued in the vein of partnership. It was intimated at the October meeting that the RPC supported the co-design approach but required further demonstration of this commitment from HBRC in terms of the co-development of the Project Brief.

Project Progress: November – December 2020

- 9. Preliminary public consultation on catchment values and issues was undertaken in November and early December 2020. This series of hui was led by the project team which included HBRC staff and Bonny Hatami (NPDT). Sixty-six people are recorded as attending the four public hui/meetings held at Te Pohue, Wairoa, Mohaka and Napier and two separate farmer meetings (Puketitiri and Taharua).
- 10. A draft collation of the information collected from the hui/meetings has been provided to participants for review. An online survey was made available on the HBRC Mohaka webpage based on those meetings and was used to collect further information on outcomes and issues.

Project Progress: January - March 2020

- 11. Following an internal review of this engagement process and further consideration of the work programme, NPDT took the opportunity to consider what resourcing they would require to effectively participate in the process and to enable them to be involved in all aspects of the plan making process going forward. NPDT on behalf of iwi/hapū of the Mohaka catchment have designed a Māori-led workstream and programme of work which will inform the plan development, which HBRC made a financial commitment to support. The Māori-led workstream will deliver a number of components which will be key to plan development, these include (in summary):
 - 11.1. Creation of Pou to guide plan development analysis of existing tangata whenua visions, documents, and strategies. Pou to specifically relate to the Te Mana o Te Wai concept and principles of Mana Whakahaere, Kaitiakitanga and Manaakitanga
 - 11.2. Wananga with wider tangata whenua of the catchment development of the local definitions of Te Mana o Te Wai, the long-term vision for the catchment, values, and environmental outcomes.
 - 11.3. Capturing the aspirations and initiatives, tools and options for tangata whenua for management of freshwater in Mohaka catchment. Presenting these back to HBRC and the RPC.
 - 11.4. Assessment of the values against the science data and mātauranga māori to determine where Māori freshwater values need to be protected and where improvements are needed from a tangata whenua perspective
 - 11.5. Draft options for attributes, targets and monitoring which will support the tangata whenua values, environmental outcomes, and vision.
 - 11.6. Work with HBRC staff to weave these elements into the plan, negotiating shared values, attributes, targets, and options for limits.
 - 11.7. Draft policies, methods and rules which support the desired state for the Mohaka from a tangata whenua perspective.
 - 11.8. Work with HBRC to weave these elements into the Mohaka Chapter and Kotahi regional policy statement and plan to ensure that tangata whenua values, outcomes and visions are embedded in the Kotahi.
- 12. At the request of the Te Pohue Community a further public meeting is being held on the 25 March 2021. The Waihua catchment has been incorporated into the Mohaka catchment area for the purposes of engaging with the community there.

Central Government Direction 2021

- 13. Earlier this year Central Government announced its plans to repeal the RMA and replace it with three new Acts (Natural and Built Environments Act, Strategic Planning Act, and the Climate Change Adaptation Act). Minister Parker announced in February that he will engage with iwi/Māori to refine policy options as proposals are developed. Staff presented a paper to the RPC at its last meeting in March 2021 on the 'Resource Management Reform Announcements'.
- 14. Staff wish to highlight that at the time of writing this paper it remains unclear what this engagement will look like for Hawke's Bay (including Mohaka) iwi. That being said, the government has noted that it is important to keep current systems operating and continue to implement key pieces of national direction such as the NPSFM, with a particular emphasis on gathering evidence/data on plan performance and establishing implementation practices that could be carried over into a future system. We anticipate that the exposure draft for the NBA will be released in May of this year. Staff will continue to provide updates as and when they become available.

Discussion

- 15. The initial project brief has been amended in response to the need for additional tangata whenua resourcing and to more clearly articulate how the co-design process will work.
- 16. The schedule of works has been revised to identify the separate two strands of work, one being led by tangata whenua and the other by HBRC, with each strand connecting as necessary (the middle column of the schedule) to ensure that there is effective integration for both Kotahi (the resource management plan for the region) and the action plan for the catchment. This model of working in partnership aligns with one of the Principles which was explored by the RPC at the workshop in December He waka hourua, which translates as the double hulled canoe, which is an analogy meaning a partnership where two people/groups are working together towards the same common goal/objective, but also recognising that they are different and retaining their own sense of identity.
- 17. The amended Mohaka project brief is sufficiently flexible to stay focused on the outcomes for the Mohaka Catchment, while still being responsive to legislative change.

Next Steps

- 18. A contract is being refined (at the time of writing this paper) and soon to be agreed. This relates directly to the work outlined above in the Māori-led workstream and the resourcing required by NPDT to support this. This will provide the additional resourcing for tangata whenua to undertake more detailed work with iwi and hapū through wananga to identify what it means to give effect to Te Mana o Te Wai locally and allowing for the collection of mātauranga in a way that can best contribute to the plan making process.
- 19. There are milestones identified in the programme of work including where reports will be provided to the Regional Planning Committee. The work programme (attachment 1 to the project brief) outlines the various next steps and significant milestones for the project. Where there are no substantive reports to present the RPC will be kept informed of progress in the interim via the standing item 'Resource Management Policy Projects'.
- 20. Preliminary results from hui, public meetings and the online survey will be provided to the RPC at its next meeting in June.

21. Staff have assessed the requirements of the Local Government Act 2002 in relation to this item and have concluded that, as this report is for information only, the decision-making provisions do not apply.

Recommendation

Introduction

1.1 Purpose

The Project Brief sets out the process for the co-design of the Mohaka Chapter of Kotahi¹. This will set out how HBRC and the NPDT (on behalf of iwi/hapū) will work in partnership to develop the planning provisions for managing land and freshwater within the Mohaka Catchment which:

- · gives effect to the National Policy Statement for Freshwater Management 2020, and
- · provides for the needs and aspirations of tangata whenua and catchment communities.

This project is the first of its kind for the Hawkes Bay Regional Council, in terms of adopting a co-design process for developing catchment-specific provisions, under the guidance of the Hawke's Bay Regional Council (HBRC) and tangata whenua representatives of the Regional Planning Committee.

The 'Mohaka Co-Design Plan Development' project is part of a wider review of review the operative Regional Resource Management Plan (RRMP) and Regional Coastal Environment Plan (RCEP). The Mohaka project will focus on Mohaka Catchment and sub-catchment detail while also considering region-wide provisions relating to the integrated management of the natural and physical resources.

1.3 Co-design

Co-design envisages a dual but connected pathway for developing the Mohaka Chapter within Kotahi and clear expression of Te Mana o te Wai in the proposed Mohaka regional plan provisions, agreed between the co-design partners.



Both the process used, and the proposed plan provisions will be developed using the following principles: In working together in co-design and in matters relating to this Agreement, the Parties agree to act in accordance with the following guiding principles:

- a) Partnership
- b) Rangatiratanga (leadership)
- c) Kawanatanga (governance)
- d) Whakawhanaungatanga (relationships)
- e) Good faith
- f) Honesty
- g) Respect
- h) Integrity
- i) Openness
- j) Reasonableness
- k) Mutual benefit

2. Project Background

2.1 History

The RRMP was made operative in 2006, with plan change 5 (notified in 2012 and operative from 2019) setting out an approach to integrated catchment management tailored to specific catchments across the region.

Declining water quality in the Taharua sub catchment triggered a Council response back in 2009, when HBRC established a Taharua Stakeholder Reference Group. That group produced a Taharua and Upper Mohaka Draft Strategy in July 2011. Farmers implemented several practices to reduce their discharges of nitrogen which resulted in an improvement in water quality, albeit for a few years only.

By February 2015, the project scope was extended to cover the whole Mohaka Catchment, envisaging a 'ki uta ki tai' approach. In September 2016 a new Project Plan was adopted by HBRC which included a Tangata Whenua Advisory Group.

The Mohaka Reference Group met once in late 2016, but no further progress was made as other plan change work was given higher priority.

In May 2019, HBRC met with tangata whenua representatives from the catchment to discuss the option of developing the plan using a co-design approach. There was general support for this new way of working. The co-design approach was to be initiated with a staff member from Ngati Pahauwera Development Trust to represent iwi and hapu interests, acting as a conduit for information exchange and to work in partnership with the HBRC project team in the plan development, on behalf of tangata whenua.

The co-design process for the Plan development for the Mohaka Catchment has been continually evolving as this is a new way of working together for both tangata whenua and HBRC. To date it has been an iterative process, drawing on the strengths of both parties, developing new ways of working together and supporting each other in the process of plan development.

The co-design plan development process has been designed to better reflect:

- The functions of the Regional Planning Committee as co-design partners in decision making;
- The need to improve the way HBRC work in partnership with tangata whenua to actively involve them in resource management;
- Learnings gained from recent plan development and engagement processes elsewhere across the region; whilst
- 4. Acknowledging that this is a new way of working, which is constantly evolving as we explore the learnings from working together, developing the co-design process and nurturing the partnership, while ensuring that we maintain the agility and flexibility to respond to new ideas, challenges and approaches as they arise.

The Project Brief (version 1.3) has being revised to better reflect the co-design process and to incorporate the requirements of various new land and freshwater regulations, including the National Policy Statement for Freshwater Management (NPS-FM 2020).

3. Business Case Outline

3.1 Project Vision

A healthy and vibrant environment, and a resilient and prosperous community.

3.2 Project Outcome

A Mohaka specific chapter for incorporation within Kotahi (Regional Plan for Hawkes Bay) provides the policy framework for managing natural and physical resources in an integrated manner that prioritises water quality, sustainable land use, biodiversity and ecosystem health, as well as the needs of people in the Mohaka catchment.

3.3 Project Objectives

Objective 1: An integrated catchment management regime is prepared for the Mohaka water bodies, including all tributaries and groundwater, with particular focus on achieving good quality water in all water bodies and an initial path forward to mitigate or adapt to the effects of climate change.

Objective 2: A policy framework that supports sustainable land management, recognising the role of kaitiaki and stewards of the catchment, further developing an understanding of the environmental impacts of land use, exploring ways to reduce these impacts and implementing good practices.

Objective 3: A policy framework that ensures that the land and coastal waters are of good quality, meeting national objectives for management and tangata whenua and community aspirations for water, land and coastal natural resources.

Objective 4: Tangata whenua co-design the plan making process and draft proposed regional plan provisions (to pre-notification) with HBRC.

Objective 5: Stakeholders and those using and enjoying the Mohaka catchment are effectively engaged in:

- Taking actions to maintain or improve catchment natural resources, collectively or individually
- Plan change preparation providing input to identify catchment level objectives, policies
 to achieve those objectives, rules and other methods to give effect to those policies,
 within the wider regional and national planning frameworks
- Monitoring and review of the impacts, efficiencies and effectiveness of initiatives undertaken.

Objective 6: Mohaka plan provisions are developed within the context of the wider review of the RRMP and RCEP (Kotahi).

3.4 Outputs

Key Output 1: The Mohaka catchment management regime will be given regulatory effect through necessary changes to the land and freshwater provisions in the regional plan for Hawke's Bay.

Key Output 2: A Mohaka Catchment Action Plan will identify non-regulatory catchment actions (by HBRC and others) to achieve the long-term catchment visions and outcomes identified in the regional plan.

3.5 Business Justification

Plan development work is necessary for the Mohaka catchment to:

- Achieve integrated and effective management of the natural and physical resources of the Mohaka Catchment
- 2. Give effect to the NPS-FM 2020 with respect to the Mohaka catchment
- Give effect to changes currently being developed within the Regional Policy Statement section of the RRMP with respect to protecting identified outstanding water bodies
- Ensure that the regional plan provides for more stringent rules than allowed for in national environmental standards, where necessary to protect natural resources within the catchment
- Take into account any relevant planning document recognised by an iwi authority within the Mohaka catchment.

The NPS-FM 2020 sets out the land and freshwater plan making process in general terms, including requiring that plans give effect to Te Mana o Te Wai (NPS-FM 2020) and that tangata whenua are actively involved in freshwater management and the community are engaged at each step of plan development (NPS-FM 2020 Policy 2 and the NOF Process NPS-FM 3.7(1)).

All plan provisions to give effect to the NPS-FM must be undertaken as soon as reasonably practicable (NPS-FM 4.1), follow the freshwater planning process (s80A(1) RMA) and be publicly notified by 31 December 2024 (s80A(4)(b) RMA).

The National Planning Standards require that regional plans adhere to certain drafting standards, included standard terms (if defined nationally) and the structure of any regional policy statement and plan.

The Māori-led workstream recognises the statutory requirements for the plan making process as outlined above, and consequently has been developed in such a way that appropriate resources are provided to support expert input into the plan drafting with a Te Ao Māori lens.

3.6 Strategic Alignment

The project contributes to three of the Council's strategic priority focus areas for 2020-2025:

- 1. Water quality, safety and security
- 2. Smart and sustainable land use
- 3. Healthy, functioning biodiversity.

This project contributes towards achieving a number of the strategic goals associated with each of these focus areas.

The creation of the Pou will identify those strategic priorities for iwi/hapū in the Mohaka catchment. This workstream is the first priority for the Māori-led programme and will guide plan development. It will provide an analysis of existing tāngata whenua visions, documents and strategies. The Pou will specifically relate to the Te Mana o Te Wai concept and principles of Mana Whakahaere, Kaitiakitanga and Manaakitanga.

3.7 Budget and Resources

The policy development work is provided for in the Years 2-5 of the Long Term Plan 2018-2028 through workstream 192 (Strategy and Planning).

Additional funding is being sought to support tangata whenua involvement via the LTP 2021-2031 through two workstreams – the Policy & Planning workstream for Kotahi and Māori Partnerships.

It is recognised that this new co-design approach to working will require appropriate funding to support the Māori-led workstream. There will be funding requirements necessary to HBRC & NPDT Project Brief: Mohaka Co-Design Plan Development DRAFT v1.3

support for instance the creation of the Pou, involvement in policy drafting, wananga whereby the expression of passing down of knowledge and matauranga Māori will occur and development of management options.

Matauranga Māori is likely to come in many forms – it is yet unclear how this will be expressed in the Mohaka plan development specifically, whether it is through implementation, recording or giving effect to. This body of work is likely to be embarked upon and will identify a future work programme which extends beyond the notification of Kotahi by December 2024.

4. Project Benefits

4.1 Success Measures

Success will be measured where the co-design process and the planning provisions for the Mohaka catchment achieve the following:

- 1. Plan provisions which are legally compliant and meet all statutory process requirements
- 2. The relationship with tangata whenua is nurtured and enhanced through co-design
- 3. Te Mana o Te Wai is effectively expressed for the catchment and the region
- 4. Successfully managing and meeting the expectations of the Regional Planning Committee and t\u00e4ngata whenua, particularly with regards to engagement. Managing community expectations will require management. One of the measures of success will be an understanding and appreciation of the limitations of the plan and acceptance of communicating via different methods e.g. social media where this is practical, effective and efficient.
- 5. Kotahi is notified within the timeline agreed in this project plan
- The project is satisfactorily managed with respect to risk, with any resource issues clearly identified, to the satisfaction of the project sponsors
- The Mohaka policy is supported by an Action Plan for which includes non-statutorily
 prescribed actions beneficial to achieving good environmental, farming, iwi and
 community outcomes.

5. Project Scope

5.1 In Scope and Out of Scope

5.2 Constraints and Assumptions

This plan development work assumes that:

- An Engagement Plan for Kotahi which is satisfactory to both tangata whenua and the Regional Planning Committee will be developed to support co-design;
- Project staff will be available intermittently for this and the next financial years (1 July 2020 to 30 June 2022);
- Sufficient resourcing is provided within the Long Term Plan 2018-2028 (Years 2&3) and LTP 2021-2031 to support the notification of Kotahi (incorporating a Mohaka Catchment chapter) within the timeline set in this Project Plan;
- 4. Project team continues to work together (with appropriate mandate) acknowledging that the co-design concept is evolving, and that HBRC and NPDT will commit to working together on the principles of flexibility, openness and forgiveness. That there is a good vision as we embark on co-design of how we intend to work together with a common end goal;
- Matauranga Māori and the action plan will be developed in support of the policy development;
- New national direction including for example the NPS-IB and the replacement of the RMA is likely to create additional work to reconcile proposed plan provisions with the new national directions and establish where stringency is required.

6. Project Schedule

6.1 Approach

The pre-notification project process will be co-designed with tangata whenua, who will be involved at every stage of the Plan development process.

6.2 Deliverables

The main deliverable will be a co-designed Mohaka chapter for incorporation within Kotahi (Regional Plan for Hawkes Bay).

Attachment 1 – Mohaka Plan Development: Tängata whenua & HBRC Programme of Work outlines the numerous other deliverables for this project. This programme outlines the deliverable from both the Māori-led workstream, the joint working and HBRC led workstreams.



 - 2.2. district plan reviews or district plan changes released by a territorial authority
 - 2.3. private plan change requests publicly notified by a territorial authority
 - 2.4. notices of requirements for designations in district plans
 - 2.5. non-statutory strategies, structure plans, registrations, etc prepared by territorial authorities, government ministries or other agencies involved in resource management.
- 3. In all cases, the Regional Council is <u>not</u> the decision-maker, applicant nor proponent. In the Statutory Advocacy project, the Regional Council is purely an agency with an opportunity to make comments or lodge submissions on others' proposals. The Council's position in relation to such proposals is informed by the Council's own Plans, Policies and Strategies, plus its land ownership or asset management interests.
- 4. The summary outlines those proposals that the Council's Statutory Advocacy project is currently actively engaged in.

Decision Making Process

5. Staff have assessed the requirements of the Local Government Act 2002 in relation to this item and have concluded that, as this report is for information only, the decision-making provisions do not apply.
