#### 6. Hawke's Bay CDEM Group Annual Report 2019-20

Ian Macdonald introduced the item and provided a brief overview of the events impacting on budgets over the year. Discussions and queries traversed:

- Increasing number of significant events and how to build up disaster relief funds in preparation
- Budgets are okay at present but getting tight, and looking to identify and fill gaps through the HBRC LTP process
- Requesting budget forecasts come to this Group to ensure comfort that CDEM is adequately resourced.

# CDE9/20 Resolutions

That the Hawke's Bay CDEM Group Joint Committee:

- 1. Receives and considers the "Hawke's Bay CDEM Group Annual Report 2019-20" staff report.

## 8. Covid-19 Resurgence Planning and Napier Flood Response And Recovery

Ian Macdonald introduced the item, speaking to the Napier flood response first and providing the latest Napier City Council sit-rep and a run-down on the timelines of the event including when heavy rain warnings were issued, highlighting:

- 9 November, 5.45pm FENS advised unable to meet current 111 demand and prioritising calls where threat to life was posed
- 9 November, 6.15pm GECC activated, 7.30pm Emergency Services Coordination Committee recommended State of Emergency declaration, and 8.10pm Napier Mayor declared a local State of Emergency
- 10 November focus for day was situational awareness with Napier Hill priority, welfare system established, Napier fire station designated incident control point and coordination centre for USAR rapid damage assessments, Kennedy Park confirmed as evacuation centre and Minister arrived at 8pm
- 11 November, deployed multi-disciplinary teams incl welfare, USAR and Building officers to Marewa, Maraenui, Pirimai and Onekawa and detailed slip assessments on Napier Hill
- 13 November, multi-agency Civil Defence Centre in Marewa shops opened, State of Emergency lifted at 6pm
- Most welfare referrals received on Wednesday 11 November majority from Marewa (164) – shelter and food key requirements in week 1
- 50-50% insured and not insured is worrying because if you don't have insurance you may not be eligible for some assistance from MBIE (e.g. temporary accommodation funding)
- GECC Response Transition Report issued 20 November
- Richard Munneke, Recovery Manager, noted that the people (staff) working on recovery are the same ones that dealt with the response and are tired; focus of recovery initially on welfare and building assessments with view to getting communities to move into recovery themselves
- Issue causing the most grief currently is transition from emergency to temporary accommodation
- GECC will continue to support recovery and start 'debrief' and post event hazard and action processes
- 55 families at Kennedy Park & Angus Inn, and 115 uninhabitable homes currently
- Concerns raised in relation to managing resources to get necessary post event reports and debriefs required while taking staff welfare into account

- CEs have started conversations in relation to the processes to support recovery including staff resourcing
- Advocate for 'navigators' who assist people to navigate insurance, health, accommodation and other assistance processes
