### Subject: Natural Hazards draft plan change

#### **Reason for report**

 This report provides essential background and updates on our Natural Hazards planning work, preparing RPC committee members for the upcoming workshop on the draft Natural Hazards chapter.

#### **Executive summary**

- 2. Due to Cyclone Gabrielle impacts and recent legislative restrictions on plan changes, the Kotahi work program was refocused to prioritise the RPS Natural Hazards chapter currently one of the only areas where plan changes remain permitted. Working closely with JTOG and territorial authorities, we have developed a draft chapter that provides stronger regional policy direction to support local hazard management decisions.
- 3. The objective of the workshop is to;
  - 3.1. Review the proposed natural hazards policies
  - 3.2. Seek approval on policy direction
  - 3.3. Focus on polices 5, 6, and 7 addressing activity restrictions within hazard risk areas.

#### **Background**

- 4. Prior to Cyclone Gabrielle, it was intended to develop the Kotahi Plan a single, integrated document combining the Regional Policy Statement (RPS), Regional Resource Management Plan, and Regional Coastal Environment Plan. A key driver for this work was the regional freshwater planning requirements and the then-December 2024 deadline for notifying new freshwater plans.
- 5. The impacts of Cyclone Gabrielle significantly disrupted the Kotahi Plan development, as efforts shifted toward supporting the region's response and recovery. Furthermore, the timeline for notifying regional freshwater plans was first extended, delayed, and finally subject to legislative amendments that prohibited notification of regional freshwater plans.
- 6. At this stage (May 2025), the RPC committee agreed to proceed with a targeted change to the operative RPS. The focus was narrowed to four priority areas: Hazards & Risk, Climate Change, Urban Form & Development, and Energy, Infrastructure & Transport. A supporting work programme was developed accordingly.
- 7. More recently, the Government announced its intention to replace the Resource Management Act 1991 with two new pieces of legislation and introduced amendments preventing councils from undertaking plan changes, with an exemption for natural hazards. In response, the RPC decided to redirect its work programme once again, this time prioritising the RPS Natural Hazards chapter.
- 8. Natural hazards, particularly issues and objectives, have been discussed with RPC previously as part of the Kotahi Plan development. The most recent being November 2024, where we held workshops with RPC Governors and received valuable feedback.
- 9. From early 2025 to now, development of the draft Natural Hazards chapter has involved ongoing engagement and hui with the JTOG and territorial authorities on policy drafting. The JTOG have provided valuable korero on matters of importance to mana whenua and this has

- been incorporated into draft provisions to date. Territorial authorities' planning staff have also provided valued input, particularly Napier City Council and Hastings District Council, both of which are undertaking natural hazard related plan changes in their respective districts.
- 10. Territorial authorities have communicated that they are not seeking changes to the current roles and responsibilities in relation to natural hazards. Rather, territorial authorities planning staff have requested stronger policy direction within the RPS to empower and support them to set their rules for the management of natural hazard risk across the region.
- 11. The approach taken to date was endorsed at the previous RPC meeting in August. This was to continue to develop the draft Natural Hazards chapter together with JTOG and territorial authorities' input, and for HBRC Policy and Planning staff to hold workshops with the RPC on the draft chapter so that committee members can review proposed provisions and provide policy direction.

#### Discussion

- 12. The purpose of this Natural Hazards workshop is for RPC committee members to review proposed provisions, and for HBRC Policy and Planning staff to seek approval on policy direction. Given the substantial amount of material to review, the workshop has been designed to focus primarily on policies and policy direction, building on the foundation of work already completed on issues and objectives.
- 13. To help break down individual policies and potential direction in the workshop, slides have been created that identify:
  - 13.1. The proposed individual policy name, content, and purpose.
  - 13.2. Any questions that relate to policy direction.
  - 13.3. Links to relevant proposed objectives and documents such as the Hawke's Bay Independent Flood Review or Clifton to Tangoio Coastal Hazards Strategy.
- 14. For policies (POL NH) 5, 6, and 7 a qualitative options analysis has been undertaken highlighting potential environmental, social, and economic costs or benefits. These policies relate to new activities within different natural hazard risk levels (very high, high etc.) in relation to varying natural hazards (flooding, tsunami, coastal hazards etc.), therefore form an integral part of the draft chapter. Together with the slides, the options analysis provides a starting point for conversation around confirming the proposed policy direction or developing new options moving forward.
- 15. The draft Natural Hazards chapter, draft Schedule (risk level methodology and matrix), and options analysis for policies 5, 6, and 7 have been attached to this paper.
- 16. To maximise the effectiveness of the workshop, committee members are encouraged to review the attached slides and draft material in advance. Additionally, it is requested that any pātai should be submitted prior to the workshop to ensure comprehensive responses can be prepared using the most current and accurate information available.

#### **Next steps**

- 17. Continue to engage with the JTOG and territorial authorities to develop provisions, subject to the direction being approved during the workshop. We will also continue to engage with RPC as we progress towards a final draft for notification.
- 18. HBRC Policy and Planning staff propose another workshop with RPC committee members to report back draft Natural Hazards chapter updates, including any approved policy direction that has been incorporated into provisions.
- 19. Finally, national direction in the form of the proposed NPS-Natural Hazards has not yet been made public. There are some key aspects in the proposed NPS, subject to change, that the draft Natural Hazards chapter will need to align with or differentiate from. One key aspect is the risk

matrix and the determination of what is very high, high, medium, or low natural hazard risk. Once the proposed NPS-NH has come into effect, there will need to be a determination whether the risk matrix (and corresponding risk levels) is fit for purpose in Hawke's Bay.
